2. Business Arising

Topics for a Board education session in December were discussed. Restorative justice and/or basic governance training were suggested. The Executive Committee will arrange a session.

The following Motion was discussed:

MOTION: That the Board adopt the following:

- 1) WHEREAS the events in Israel and Gaza have triggered a humanitarian crisis affecting over 2.3 million people, of whom 192 are health care workers who have been killed as of Nov. 7; and
- WHEREAS many families in B.C. have migrated here from the Middle East and are emotionally and psychologically impacted by the ongoing and traumatic circumstances confronting their loved ones;
- 3) THEREFORE BE IT RESOLVED that the REACH Board of Directors call on Premier David Eby to request that the federal government demand an immediate ceasefire in Gaza, Israel and the West Bank, the release of all hostages and resumption of the flow of humanitarian aid to those who need it; and
- 4) BE IT FURTHER RESOLVED that the Board urge the BC Ministry of Health, the Ministry of Mental Health and Addictions, and the Ministry of Social Development and Poverty Reduction to make emergency support services available to residents whose families have been impacted by events which began on October 7 and are ongoing, as well as to any released hostages who are living in British Columbia; and
- 5) BE IT FINALLY RESOLVED that the Minister of Health direct the B.C. Public Health Agency to work with and fund community health centres in B.C. to reach out to the Palestinian and Jewish communities within their respective jurisdictions with health and social care services that may be required.
